

## **Building Plot at Homeland Orcop Herefordshire HR2 8SD**

An excellent Freehold building plot in a lovely rural location, with a pleasant outlook, within the village of Orcop which lies between the Cathedral City of Hereford (10 miles), Ross-on-Wye (10 miles) and Monmouth (11 miles).

### **The Plot**

The plot has a frontage of 30 metres and a maximum depth of 30 metres and is slightly elevated and predominantly level, being part of the former garden to the adjoining property known as Homeland.

### **Planning permission**

Outline Planning Consent was approved on the 8th November 2017 (Application number 172896) a copy of this permission is enclosed within these sale particulars. We draw particular attention to conditions 1-9 within the consent.

### **Services**

It is understood that mains electricity and water are available for connection; the purchaser must satisfy themselves as to the cost and availability. Drainage will be by a private drainage system to be installed by the purchasers.

### **Viewing**

By site inspection at any reasonable daylight hour.

### **Directions**

From Hereford proceed south on the A49 towards Ross-on-Wye, continue to the top of the Callow Hill and then turn right, signposted Monmouth (A466). Proceed through Wormelow and turn right signposted Orcop. Continue into Orcop Hill and turn right by the stone bus shelter and former telephone kiosk, and the building plot is located on the right-hand side after about 500 yards.

### **Agents note**

1. Access to the plot is via a new shared splayed drive. The purchaser of the property will be responsible for constructing the new shared access for the plot and Homeland.
2. The purchaser will be responsible for erecting a boundary fence between point A and B as shown on the plan.

3. All plans and maps are for illustration purpose and for guidance only.
