Outside at the front there is driveway parking and there is a side door providing access to an excellent size back garden. The house is being sold with the benefit of NO UPWARD CHAIN.

FRONT

A dropped curb gives access to a paved driveway, hedging to side boundaries, PVC double glazed door to the side elevation and a PVC double glazed door gives access to the porch.

PORCH

Wall mounted light point, a carpeted floor and a composite door gives access to the stairs lobby.

STAIRS LOBBY

Ceiling light point, wall mounted electricity meter, wall mounted consumer unit, carpeted stairs with handrail to the first floor landing, carpeted floor and door to the living room.

LIVING ROOM 16' 9" into bay window x 13' 9" into chimney breast recess (5.10m x 4.19m)

PVC double glazed bay window to the front elevation, ceiling light point, single panel radiator, carpeted floor and doors to the breakfast kitchen and understairs store.

BREAKFAST KITCHEN 9' 6" x 17' 1" (2.89m x 5.20m)

PVC double glazed window and a PVC double glazed obscured glass door to the rear elevation, ceiling spot light fittings, wall mounted cupboards one of the cupboard houses a 'Worcester' combi gas fired central heating boiler, floor mounted cupboards and drawers, worksurfaces to three sides, tiled splash backs, a stainless steel single bowl single drainer sink unit with mixer tap, an integrated four ring electric hob with an electric oven below and a stainless steel and glass cooker hood above, space for an upright fridge freezer, space and plumbing for an automatic washing machine, space for a tumble dryer and a vinyl floor.

PVC double glazed obscured glass window to the side elevation, ceiling spot lights, loft access point, single pane radiator, carpeted floor and doors to three bedrooms and the bathroom.

BEDROOM ONE 12' 9" x 9' 4" into chimney breast recess (3.88m x 2.84m)

PVC double glazed window to the rear elevation, ceiling light point, single panel radiator and a carpeted floor.

BEDROOM TWO 10' 9" max x 9' 11" into chimney breast recess (3.27m x 3.02m)

PVC double glazed window to the front elevation, ceiling light point, single panel radiator and a carpeted floor.

BEDROOM THREE 9' 7" x 7' 6" (2.92m x 2.28m)

PVC double glazed window to the rear elevation, ceiling light point, single panel radiator and a carpeted floor.

BATHROOM 7' 8" max x 6' 8" (2.34m x 2.03m)

PVC double glazed obscured glass window to the front elevation, ceiling spot lights, a wall mounted extractor fan, floor to ceiling tiling, bath with panelled side, mixer tap bath filler, thermostatically controlled bar shower above and a glass shower splash screen, low level W/C, pedestal wash hand basin with mirror door cupboard with lights above, ladder style towel radiator and door to a built in cupboard having shelving for storage.

BACK GARDEN

Fencing to boundaries, paved patio with paved path leading to an additional paved patio area and the rear of the garden, good sized lawn, electricity power points and a garden tap.

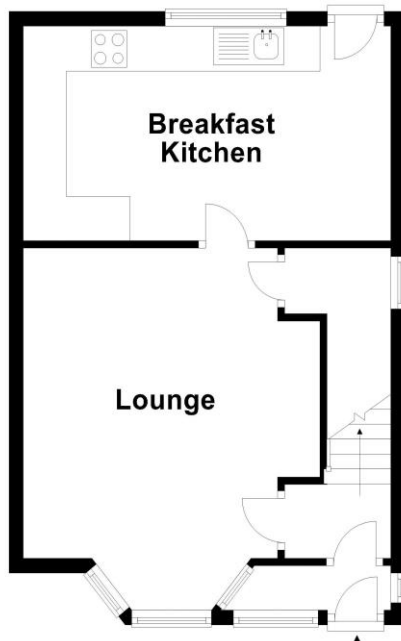

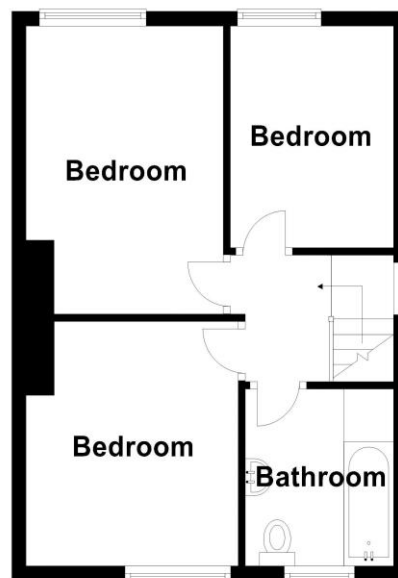
Ground Floor
