ENTRANCE HALL

Radiator. Fitted carpet. Spindled staircase to first floor.

CLOAKROOM

Obscure double glazed window. Radiator. Fitted carpet. White suite comprising of low flush WC. Pedestal wash hand basin. Tiled splashbacks.


