LOCATION

Lanchester is a thriving rural village with a population of around 4,500 people. Situated approximately 8 miles West of Durham City and 14 miles South-West of Newcastle upon Tyne.

The A691 runs through the village and provides easy access to the nearby town of Consett, the City of Durham and beyond.

The subject property occupies a prominent position on Station Road which benefits from high volumes of passing traffic.

DESCRIPTION

The building comprises an end-terrace property under a pitched slate roof. The property is arranged over two floors, with retail accommodation to the ground floor and residential on the first.

The available space comprises, a ground floor retail unit with open plan sales to the front and kitchen / WC facilities to the rear. Following their recent acquisition of the property, our client is carrying out an internal refurbishment.

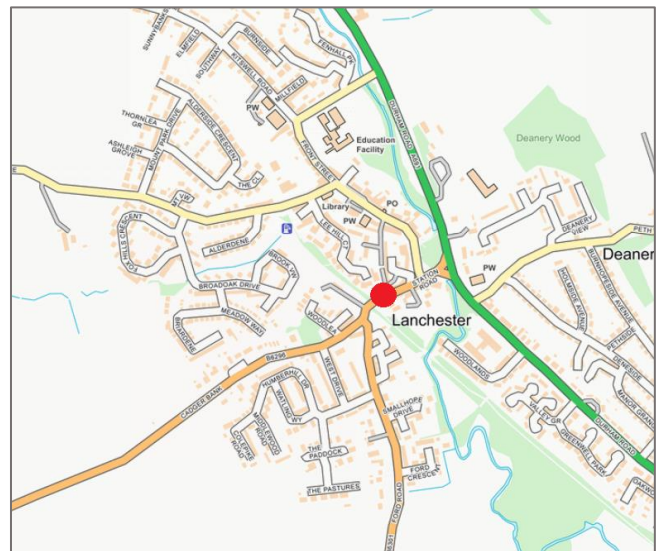
