



THE PROPERTY

Internally and to the ground floor is a spacious entrance hall, which is a great area for coats and shoes and that leads to the main hallway giving access to the cloakroom, utility room, lounge and kitchen/diner.

The rear garden is mostly laid to lawn with a gate to the rear boundary. The gate leads to a pathway that runs off to the left and around the end of the terrace.

The home is fully UPVC double glazed and warmed by an electric powered warm air heating system.
