



How this affects your energy bills

An average household would need to spend £1,369 per year on heating, hot water and lighting in this property. These costs usually make up the majority of your energy bills.

- 5,012 kWh per year for heating

Step 1: Increase loft insulation to 270 mm

Step 3: Low energy lighting

Step 4: High heat retention storage heaters

Potential rating after completing steps 1 to 4	76 C
