The accommodation is well proportioned, with living room, kitchen and guest WC to ground floor, with two bedrooms and family bathroom to the first floor. The house will be finished to a good quality standard throughout, with carpet to the living areas and vinyl flooring to kitchen and bathroom. The kitchen will be fully equipped with storage units located above and below the worktop, sink & drainer, fridge freezer, washing machine, dishwasher, oven, hob and extractor fan. The house has a private garden and parking for two cars. Heating to the property is super efficient with an air source heat pump.
