A charming two-bedroom ground floor flat pleasantly positioned offering a delightful outlook located in the picturesque Borders town of Peebles.



DESCRIPTION:

Built in the 1890s with a solid stone construction, the property offers 639 square feet of well-proportioned living space, and seamlessly blends historic charm with modern comfort. Ideally located near the bustling high street and local amenities, this versatile property is sure to be popular. Early viewing is recommended to fully appreciate its unique appeal.

Accessed through a shared entranceway to the private front door, the internal accommodation comprises; an inviting entrance hallway with classic high ceilings and a highly practical storage cupboard. Located at the back of the property, is a versatile lounge dining room which boasts a window with garden views, whilst a convenient large walk-in cupboard provides extra storage space. The kitchen features a variety of wall and base units with contrasting worktops, complemented by a stainless-steel sink beneath a rear-facing window. Integrated appliances consist of an electric oven and hob, along with an under-counter fridge. Additionally, there is available space and services for a washing machine. Currently arranged as a sitting room, the primary bedroom impresses with its ample size and traditional elements, such as ornate corning. A large bay window provides a charming and calming outlook to the front of the property whilst flooding the room with natural light. The second bedroom, though modestly sized as a small double, provides ample room for furniture and shares the same pleasant front-facing view. Completing the accommodations is the spacious bathroom, featuring a WC, wash hand basin, and a panelled bath with a mains shower overhead.

OUTSIDE:

Externally; there are private and shared gardens to the front and rear of the property. The private front garden is chipped and planted with an array of mature shrubbery bound by stone walling. At the rear, with its southern aspect i a shared seating area, an ideal setting for enjoyable alfresco dining during the summer months, a private garden area to enjoy seasonal planting, and a shared drying green. Ample unrestricted on-street parking is available at the front of the property.

LOCATION:

The Royal Burgh of Peebles is a thriving market town and the third largest town in the Borders with a population of around 9,000. Peebles is an ideal location for those looking to enjoy the country lifestyle taking full advantage of the fishing, hillwalking, mountain biking, horse riding and golf facilities that the area has to offer. There is a swimming pool, and the Gytes Leisure Centre offers a wide variety of leisure activities to suit adults and children. Glentress Forest and its popular mountain biking routes are approximately four miles east of Peebles offering excellent biking facilities. For those who enjoy the creative arts, the Eastgate Theatre & Arts Centre showcases local and international musical and artistic talent throughout the year and there are a number of popular festivals throughout the year to include the week-long Beltane Festival which is steeped in the history of Peebles and follows a traditional format, an Arts Festival, Agricultural Festival, Rugby Sevens and TweedLove Bike Festival, to name just a few. The High Street of Peebles has a wide selection of independent retailers and highly regarded restaurants as well as a number of high street favourites. The town also has a health centre, dentists, vets, banks, and supermarkets as well as primary and secondary schools. Peebles is ideally situated within commuting distance of Edinburgh which can be reached by private or public transport. There is a frequent bus service running to and from Edinburgh as well as services for Biggar, Galashiels, and nearby local towns. The A703 gives easy access to the Edinburgh City Bypass for onward travel to many destinations and Edinburgh Airport for UK or overseas travel.
