Situated within the towns conservation area, a delightful two-bedroom main door ground floor flat enjoying a central location just a short stroll away from the vibrant High Street in the picturesque Borders town of Peebles.



DESCRIPTION:

Dating back to the 1890s, this classic stone-built property offers comfortable internal accommodation spanning 506 square feet and features a charming small front garden, enhancing its appeal. Conveniently positioned close to all local amenities, this property stands out as an excellent investment opportunity or an ideal choice for first-time buyers. Early viewing is highly recommended.

The internal layout features an entrance hallway providing access to all rooms, complemented by a highly convenient storage cupboard for added functionality. Situated at the front, the open plan kitchen and living room feature a well-equipped kitchen with both wall and base units, providing space and utilities for a washing machine and undercounter fridge. Integrated appliances include an electric oven and a gas hob. The living area is bathed in natural light through two windows that offer a pleasant outlook over Cross Street. There are two bedrooms situated at the rear, one double and one single. The single bedroom is versatile and could be utilized equally well as a home office, or a nursery. Completing the accommodation is the shower room which incorporates a modern shower unit, a useful fitted vanity unit with wash hand basin, and a WC.

OUTSIDE:

Externally, the property boasts a private, easily maintained front garden, currently landscaped with decorative chips and enclosed by a combination of traditional stone walling and timber fencing. Ample unrestricted parking is conveniently available on surrounding streets.

LOCATION:

The Royal Burgh of Peebles is a thriving market town and the third largest town in the Borders with a population of around 9,000. Peebles is an ideal location for those looking to enjoy the country lifestyle taking full advantage of the fishing, hillwalking, mountain biking, horse riding and golf facilities that the area has to offer. There is a swimming pool, and the Gytes Leisure Centre offers a wide variety of leisure activities to suit adults and children. Glentress Forest and its popular mountain biking routes are approximately 4 miles east of Peebles offering excellent biking facilities. For those who enjoy the creative arts, the Eastgate Theatre & Arts Centre showcases local and international musical and artistic talent throughout the year and there are a number of popular festivals throughout the year to include the week-long Beltane Festival which is steeped in the history of Peebles and follows a traditional format, an Arts Festival, Agricultural Festival, Rugby Sevens and TweedLove Bike Festival, to name just a few. The High Street of Peebles has a wide selection of independent retailers and highly regarded restaurants as well as a number of high street favourites. The town also has a health centre, dentists, vets, banks, and supermarkets as well as primary and secondary schools. Peebles is ideally situated within commuting distance of Edinburgh which can be reached by private or public transport. There is a frequent bus service running to and from Edinburgh as well as services for Biggar, Galashiels, and nearby local towns. The A703 gives easy access to the Edinburgh City Bypass for onward travel to many destinations and Edinburgh Airport for UK or overseas travel.

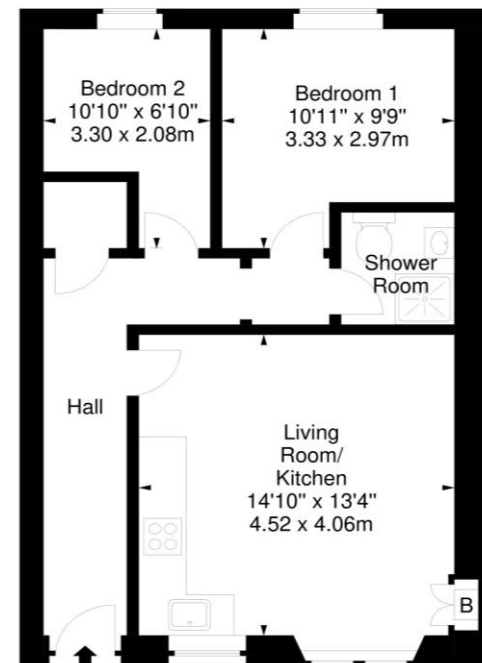
