DESCRIPTION:

In need of some cosmetic modernisation, this functional property offers well-proportioned accommodation totalling an impressive 1,005 square feet including ample storage solutions, along with further potential, to not only enhance the existing layout, but also for an attic conversion, pending necessary planning consents. Combining practicality with great potential to create and design an interior of choice, generous private garden, local amenities, parks, riverside walks nearby, and just a short walk to schooling at both levels, this flat is sure to appeal to a wide range of buyers and early viewing comes highly recommended.

Accessed from the side of the property, the internal layout comprises; an entrance hall featuring a staircase leading to the upper floor, complete with a generously sized storage area. Up on the first floor, a hallway landing provides access to all accommodations, along with ample storage solutions, and access hatch to a generous attic space. The sitting room offers a delightful blend of brightness and comfort with front-facing windows offering views over Kingsmuir Crescent and the distant countryside. A gas fire, currently disconnected, sits within a timber surround, while an adjoining door leads into the kitchen. Also accessible via the hallway, the kitchen is fitted with a variety of storage units featuring laminated worktops and a stainless-steel sink unit, whilst space and connections are available for a cooker, washing machine, and fridge freezer. The kitchen is bathed in natural light, via dual aspect windows to the front and side of the property. It is worth noting that planning permission has previously been granted to redesign the kitchen, allowing for the creation of a spacious open-plan dining kitchen. There are three generously sized double bedrooms, each boasting a bright and airy ambiance. One bedroom provides a pleasant open view to the front, while the other two enjoy windows overlooking the private garden area, and the picturesque Tweed Valley countryside to the rear. Completing the accommodation is the family bathroom, featuring a WC, wash hand basin, a P-shaped bath with an overhead shower, and a rear-facing opaque window that invites natural light into the space.

OUTSIDE:

Externally, the property boasts a generous section of private garden ground situated at the rear. Accessed via a shared pathway, the private garden is predominantly laid to lawn surrounded by a vast array of mature plantings, offering beautiful bursts of colour throughout spring and summer. A paved patio area offers ample space for outdoor furniture, whilst a timber garden shed provides external storage solutions. Parking is available on-street to the front of the property.

LOCATION:

The Royal Burgh of Peebles is a thriving market town and the third largest town in the Borders with a population of around 9,000. Peebles is an ideal location for those looking to enjoy the country lifestyle taking full advantage of the fishing, hillwalking, mountain biking, horse riding and golf facilities that the area has to offer. There is a swimming pool, and the Gytes Leisure Centre offers a wide variety of leisure activities to suit adults and children. Glentress Forest and its popular mountain biking routes are approximately four miles east of Peebles offering excellent biking facilities. For those who enjoy the creative arts, the Eastgate Theatre & Arts Centre showcases local and international musical and artistic talent throughout the year and there are a number of popular festivals throughout the year to include the week-long Beltane Festival which is steeped in the history of Peebles and follows a traditional format, an Arts Festival, Agricultural Festival, Rugby Sevens and TweedLove Bike Festival, to name just a few. The High Street of Peebles has a wide selection of independent retailers and highly regarded restaurants as well as a number of high street favourites. The town also has a health centre, dentists, vets, banks, and supermarkets as well as primary and secondary schools. Peebles is ideally situated within commuting distance of Edinburgh which can be reached by private or public transport. There is a frequent bus service running to and from Edinburgh as well as services for Biggar, Galashiels, and nearby local towns. The A703 gives easy access to the Edinburgh City Bypass for onward travel to many destinations and Edinburgh Airport for UK or overseas travel.


