An attractive two-bedroom main door flat positioned on the ground floor of a traditional stone built residence situated on a historic street in the picturesque Borders town of Peebles.











DESCRIPTION:

Dating back to the late 1800's on one of the oldest streets in the town, this well-proportioned property exudes charm and character with accommodation totalling 771 square feet and benefits from an extremely versatile basement room. Nestled on the tranquil one-way street of Biggiesknowe, this flat offers a peaceful retreat just moments from the lively High Street. Ideal for first-time buyers, holiday seekers, or property investors, early viewing is recommended.

Enjoying modern upgrades and a pristine, crisp white decor, this property offers a comforting internal space which comprises; an inviting entrance hallway which provides access to all accommodation, and a turning staircase leading down to the basement area. The open-plan kitchen and living room has been tastefully upgraded, featuring a modern kitchen equipped with stylish wall and base units, along with integrated appliances including an electric hob and an eye level electric oven. Space and services are provided for a free standing fridge freezer and a washing machine. The living area provides ample space for both lounge and dining furniture, with a front-facing window offering a pleasant view out over the historic street. The comfortable principal bedroom is generously sized and features a large fitted wardrobe, whilst a front-facing window welcomes plenty of natural light into the room. The second bedroom, situated at the rear, features a built-in cupboard, offering superb storage convenience. Concluding the accommodation is a bright and airy split-level bathroom featuring a WC, wash hand basin and a shower over a panelled bath. Downstairs is an exceptionally versatile basement space, a highly practical addition to this charming historic home, providing a multi-functional area with numerous possibilities.

OUTSIDE:

Externally; while the property doesn't include gardens, there's an abundance of parks, riverside walks, and leisure facilities just steps away. Parking options include on surrounding streets or in the nearby Greenside public car park, which incurs charges from Monday to Saturday.

LOCATION:

The Royal Burgh of Peebles is a thriving market town and the third largest town in the Borders with a population of around 9,000. Peebles is an ideal location for those looking to enjoy the country lifestyle taking full advantage of the fishing, hillwalking, mountain biking, horse riding and golf facilities that the area has to offer. There is a swimming pool, and the Gytes Leisure Centre offers a wide variety of leisure activities to suit adults and children. Glentress Forest and its popular mountain biking routes are approximately 4 miles east of Peebles offering excellent biking facilities. For those who enjoy the creative arts, the Eastgate Theatre & Arts Centre showcases local and international musical and artistic talent throughout the year and there are a number of popular festivals throughout the year to include the week-long Beltane Festival which is steeped in the history of Peebles and follows a traditional format, an Arts Festival, Agricultural Festival, Rugby Sevens and TweedLove Bike Festival, to name just a few. The High Street of Peebles has a wide selection of independent retailers and highly regarded restaurants as well as a number of high street favourites. The town also has a health centre, dentists, vets, banks, and supermarkets as well as primary and secondary schools. Peebles is ideally situated within commuting distance of Edinburgh which can be reached by private or public transport. There is a frequent bus service running to and from Edinburgh as well as services for Biggar, Galashiels, and nearby local towns. The A703 gives easy access to the Edinburgh City Bypass for onward travel to many destinations and Edinburgh Airport for UK or overseas travel.

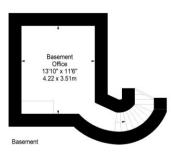

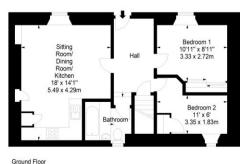
