

Primary energy use

The primary energy use for this property per year is 512 kilowatt hours per square metre (kWh/m2).

How this affects your energy bills

An average household would need to spend £5,560 per year on heating, hot water and lighting in this property. These costs usually make up the majority of your energy bills.

You could save £3,331 per year if you complete the suggested steps for improving this property's energy rating.
