
### Sectional Diagram showing elements of a typical house

### 2. Condition

Structural movement	
Repair category	1
Notes	Evidence of settlement/movement has affected the building reflected by minor cracking and a run to the internal flooring. On the basis of a single inspection this appears longstanding with no evidence of recent movement apparent.

Dampness, rot and infestation	
Repair category	2
Notes	Above average damp readings were obtained to localised sections of lower wall lining at ground floor level. A precautionary check of the entire property should be carried out by a reputable timber and damp specialist prior to purchase.
	There is evidence of previous damp/timber specialist treatment works having been carried out including damp-proofing to the front elevation. Guarantee documentation should be obtained.
	Condensation was evident to the ceiling within the shower room area at first floor level.

Chimney stacks	
Repair category	2
Notes	Weathered chimney masonry visible and future maintenance should be anticipated.
	Our inspection of chimneys was limited but they are of an age and style where a degree of regular ongoing maintenance should be anticipated.

Roofing including roof space	
Repair category	2
Notes	The pitched and slate roof covering appears to be of an age and style where a higher degree of regular and ongoing maintenance should be anticipated, with a number of weathered slates evident at the time of inspection.  There are felt roof coverings over the dormer projections and the rear algorithm.
	elevation. It should be appreciated that this type of covering can have a limited life span and will require a higher than normal degree of ongoing maintenance and eventual replacement. It may be prudent to confirm the service history of the roof covering.

Rainwater fittings	
Repair category	1
Notes	Within the limitations of our inspection rainwater goods were seen to be free from significant defect.
	We would highlight that it was not raining at the time of our inspection and we would recommend that all rainwater fittings be inspected during heavy rainfall in order to ensure they are free from defect.

Main walls	
Repair category	2
Notes	Evidence of isolated cracked rendered finishes in areas and future maintenance should be anticipated, although the vendor informed us that remedial works are to be carried out by Kingdom Coatings prior to any date of entry.  We understand the external paint finishing has a ten year guarantee any documentation should be made available.

Windows, external doors and joinery	
Repair category	1
Notes	Windows were not all fully opened or tested, and it should be appreciated that some defects are only evident during certain weather conditions.  Within the limitations of our inspection, no significant defects were noted.
	It is assumed that replacement windows and doors comply with relevant building and fire regulations.

Notes	Paint finished and decorated external surfaces will require redecoration on a regular basis.

Notes	Boundary walls and fences should be regularly checked and maintained as necessary.

Ceilings

Notes	Within the limitations of our inspection no significant defects were noted.  Textured coatings were noted to ceiling areas. On rare occasions, these materials can have an asbestos content. We have not tested these materials nor carried out an asbestos survey however, until the material is professionally tested the linings should be left undisturbed and the material handled by a competent contractor only.

Notes	Within the limitations of our inspection no significant defects were noted.

Floors including sub-floors	
Repair category	1
Notes	Due to fitted carpets and floor coverings no detailed inspection of floors was possible and accordingly no comment can be made on their condition.
	Flooring was noted to be uneven in areas underfoot.

Internal joinery and kitchen fittings

Notes	Within the limitations of our inspection no significant defects were noted.
	Low level internal glazing should be checked for safety glass.

Chimney breasts and fireplaces

Notes	No significant defect noted.

Electricity

Notes	The Institution of Engineering Technology recommends that inspections and testings are undertaken at least every five years and on a change of occupancy. It should be appreciated that only the most recently constructed or re-wired properties will have installations which fully comply with IET regulations.  Aspects of the electrical installation are of mixed age and the system should be checked as a precaution by a registered electrician and upgraded if necessary

Gas	
Repair category	1
Notes	In the interests of safety and in light of recent regulations it would be prudent to have all gas appliances checked by a Gas Safe registered contractor.

Water, plumbing and bathroom fittings	
Repair category	1
Notes	No tests have been undertaken of the system, however within the limitations of our inspection, no significant defects were noted. No inspection has been possible to enclosed timbers beneath wet appliances and no comment has been made on the condition of unseen areas. Watertight seals will require to be regularly checked and replaced, to prevent water damage to adjoining areas.  The cold water rising main was not fully inspectable.

Heating and hot water	
Repair category	1
Notes	It is assumed that the central heating system has been properly installed, updated and maintained to meet with all current regulations and standards with particular regard to fluing and ventilation requirements. Service records should be obtained and checked. In the absence of service documentation further advice should be obtained from a qualified heating engineer to ascertain the condition, efficiency, and life expectancy of the system.  We understand the system has been serviced on an annual basis and we would advise that all service documentation be obtained and authenticated at the point of sale.

Notes	All foul and surface water drainage is assumed to be to the main public sewer. The system was not tested.

#### Category 3

Urgent repairs or replacement are needed now. Failure to deal with them may cause problems to other parts of the property or cause a safety hazard. Estimates for repairs or replacement are needed now.

No immediate action or repair is needed.

#### Remember

The cost of repairs may influence the amount someone is prepared to pay for the property. We recommend that relevant estimates and reports are obtained in your own name.

#### Warning

If left unattended, even for a relatively short period, Category 2 repairs can rapidly develop into more serious Category 3 repairs. The existence of Category 2 or Category 3 repairs may have an adverse effect on marketability, value and the sale price ultimately achieved for the property. This is particularly true during slow market conditions where the effect can be considerable.

#### 3. Accessibility information

#### Guidance notes on accessibility information

Three steps or fewer to a main entrance door of the property:

In flatted developments the 'main entrance' would be the flat's own entrance door, not the external door to the communal stair. The 'three steps or fewer' are counted from external ground level to the flat's entrance door. Wherea lift is present, the count is based on the number of steps climbed when using the lift.

#### Unrestricted parking within 25 metres:

For this purpose, 'Unrestricted parking' includes parking available by means of a parking permit. Restricted parking includes parking that is subject to parking restrictions, as indicated by the presence of solid yellow, red or white lines at the edge of the road or by a parking control sign, parking meters or other coin-operated machines.

#### 4. Valuation and conveyancer issues

This section highlights information that should be checked with a solicitor or licensed conveyancer. It also gives an opinion of market value and an estimated reinstatement cost for insurance purposes.

#### Matters for a solicitor or licensed conveyancer

The property has been altered and extended to form its current layout and it should be confirmed that all necessary permissions have been obtained.

It is assumed that all alterations, additions and/or extensions to the property have received all necessary Town Planning (Planning Permission) and Building Authority (Building Warrants and Completion Certificate) approvals and that documentation for such is available

The property is situated in an area of past mining activity. A mining report should be obtained from the Coal Authority to provide information as to historic and future mining activity and whether the property has been the subject of any compensation claims and to confirm that the property is not adversely affected.

We understand the property previous remedial works have been carried out to the property which are under guarantee, including damp-proofing and the external render and any relevant documentation should be made available within the Deeds.

Where defects or repairs have been identified within this report it is recommended that, prior to entering into any legally binding sale or purchase contract, further specialist's or contractor's advice and estimates should be obtained, to establish the implications, if any, on a potential offer to purchase or the sale price likely to be achieved for the property.

It is assumed that there are no statutory, town planning, road proposals or environmental matters which are likely to have an adverse effect on the property.

The road and footpath adjoining the site are made up and are assumed to be adopted by the Local Authority.

#### Estimated reinstatement cost for insurance purposes

For Reinstatement Cost Assessment purposes, it is recommended that the subjects be insured for a sum of not less than £525,000 (FIVE HUNDRED & TWENTY FIVE THOUSAND POUNDS) STERLING.

This figure is the estimate of the cost of rebuilding the premises and bears no direct relationship to current market value.

#### Valuation and market comments

Having considered matters, taking account of our general observations on site, we are of the opinion that the Market Value of the subjects in their present condition and with the benefit of vacant possession may be fairly stated in the sum of £220,000 (TWO HUNDRED & TWENTY THOUSAND POUNDS) STERLING.
