

Rules on letting this property


Properties can be let if they have an energy rating from A to E.

Energy efficiency rating for this property

Properties are given a rating from A (most efficient) to G (least efficient).

Properties are also given a score. The higher the number the lower your fuel bills are likely to be.

Primary energy use

The primary energy use for this property per year is 307 kilowatt hours per square metre (kWh/m2).

Environmental impact of this property
