



There are four off road car parking spaces, behind electric gates, which is very rare within the towns historic centre. Please note: Gates are currently being repaired and have been removed.

The property can be sold as seen, as it has been fitted to a very high standard. There is no forward chain, and Quay House has been completely refurbished only 7 years ago.

Located in the Priory Quarter of Christchurch, Quay House is perfectly positioned to take advantage of everything this bustling town has to offer. It falls within the shadow of the 11th-century Priory Church, reputed to have the longest parish church nave in England. The property is within walking distance of picturesque riverside walks, boating activities and the town centre, which boasts an excellent range of restaurants, cafes, bars, and High Street shops. This home serves as the perfect base from which to explore this beautiful part of Dorset.

Christchurch is a market town at the confluence of the Rivers Avon and Stour, situated in the County of Dorset and bordering Hampshire and The New Forest. There are many Blue Flag award-winning beaches within an approx. 3-mile radius such as: Southbourne beach, Avon beach, Highcliffe beach and Friar's cliff beach. Direct railway services to London Waterloo take just 1 hour and 40 minutes. Bournemouth International Airport is just 5 miles away.
